declares herewith to take over the following liabilities connected with the allocation of the right to use frequencies from the frequency bands 800 MHz, 1800 MHz and 2600 MHz based on the tender as described in the text of the invitation to tender, and undertakes to fulfil them duly and timely.

As the tenderer in the tender competition for the issue of individual permissions to use frequencies from the frequency bands 800 MHz, 1800 MHz and 2600 MHz by electronic auction I accept hereby the obligation of the national roaming in case I will be allocated in the tender such a range of frequencies that my total range in the frequency bands 800 MHz and 900 MHz, including already issued individual permissions, will exceed the size of minimum 2 * 15.0 MHz.

By this obligation I undertake to provide, by December 31st, 2018, the national roaming for the networks which use the frequencies in the frequency bands 900 MHz and 1800 MHz in favour of entitled persons who are interested in the national roaming, i.e. those to whom the following has been issued after this tender competition has been put out:

- individual permissions to use frequencies from the frequency band 1800 MHz in the minimum extent of 2 * 15.0 MHz and, at the same time, they will not be granted individual permissions to use frequencies from the frequency band 800 MHz, or
- individual permissions to use frequencies from the frequency band 800 MHz and, at the same time, they are not holders of individual permissions to use frequencies from the frequency band 900 MHz.

Unless we otherwise agree with the other party, I undertake to start providing access to the electronic communication network on the basis of my obligation concerning the national roaming, to each entitled person who is interested in the national roaming, and this not later than on the date when the following condition has been met:

 the entitled person who is interested in the national roaming through the frequencies which will be allocated to it after the date when this tender competition has been put out in the band 800 MHz and/or 1800 MHz, will cover at least 20% of the population of the Slovak Republic. In case of dispute, the fulfilment of the precondition related to the coverage by the person interested in the national roaming shall be confirmed by the Authority.

Unless we otherwise agree with the other party, my obligation to keep on providing access to the electronic communication network on the basis of my obligation concerning the national roaming to each entitled person interested in the national roaming shall cease if:

• the entitled person interested in the national roaming through the frequencies which will be allocated to it after the date when this tender competition has been put out in the frequency bands 800 MHz and/or 1800 MHz fails to cover, within 12 months after the fulfilment of the precondition according to the previous section, at least 40% of the population of the Slovak Republic, within 24 months at least 60% and, within 36 months, at least 80% of the population of the Slovak Republic. In case of dispute, the fulfilment of the precondition related to the coverage by the person interested in the national roaming shall be confirmed by the Authority.
